I am a little concerned about the differences between the request by Miles Kara and what was requested by Jeff Myers. An initial review of the strips show no SNAKE 01 or 02, but we do have strips on ELKIN 21 & SNAKE 14. Additionally, Mr. Kara requests any communication from ZBW around 0835, and communications concerning early morning fighter activity and activity related to the NEADS scramble order. Somehow, the information being requested by Mr. Kara seems to have been narrowed along the way. Since I am unsure of what to provide, can you please obtain a clarification for me of how broad or narrow our scope should be, and confirm if we are to only include transmissions with SNAKE 01 and 02 instead of all fighter activity that day.
